Montenegro: Press release: The Agency for Prevention of Corruption will Not Have Enough Resources

The Agency director reduced the already insufficient budget of the Agency for Prevention of Corruption with more than 100 000 euro. This shows that priority activities and expenses for the first year of operation of this body are being determined unrealistically and irrationally. It is clear that the current approach and the delay in filling vacancies, will significantly postpone the operability of the Agency, which is a priority of Montenegro in the negotiations process and only the first step in establishing a new framework for the prevention of corruption.

Bosnia and Herzegovina: Chiefs of Meat Grilling Empire Accused of Massive Tax Fraud

A court in Sarajevo ordered into pretrial detention two owners of a popular restaurant chain, arrested earlier this week for allegedly evading more than US\$ 3 million in taxes. According to Federal Television (FTV), a government-owned broadcaster, prosecutors said employees at the restaurants were instructed not to hand out receipts to customers unless they asked for them. FTV reports that one witness told investigators that tax authorities would be presented only 60 to 70 percent of Mrkva's revenue. According to Bosnian state television (BHRT), Mrkva

and Capin were put into pretrial custody due to the risk that they could affect the trial or abscond. **SEE, 4 December 2015.**

Montenegro Charges Ex-Mayor of Scandal-Hit Resort

Montenegro's prosecution charged the ex-mayor of the resort of Budva and nine other top officials and businessmen in a high-profile, multi-million-euro corruption case. All those accused in the high-profile corruption case have not commented on the prosecution charges so far. Radjenovic and several other local officials were arrested in August, in a case that centers on illegal construction work carried out at Jaz Beach and the TQ Plaza building in 2007 and 2008. They are suspected of using their positions for the benefit of a private company and of costing the municipal budget more than two million euro over the Jaz Beach project alone. **RAI, 2 December 2015.**

Anti-Corruption News from the SEE Region

Macedonia: Newly Formed Special Prosecution Launches its First Two Corruption Cases

The first two cases launched by the newly formed Macedonian special prosecution unit will focus on Prime Minister Nikola Gruevski and former top members of his cabinet. Macedonia's special prosecution, headed by the newly appointed Katica Janeva, began work in November with the task of investigating the cases that arose from a high-level political scandal earlier this year in which the ruling party VMRO DPMNE was accused of wiretapping more than 20,000 citizens. A series of the alleged wiretap recordings were released by opposition leader Zoran Zaev throughout spring, sparking political tensions that saw thousands turn out to protest in the streets of the capital Skopje in May. **SEE, 02 December 2015.**

Serbian Farmers Say Land Law 'Encourages Corruption'

Serbian farmers are campaigning for the withdrawal of draft legislation on agricultural land, claiming it would give the authorities unchecked powers to lease farmland to favoured investors. Most critics of the new draft have targeted Article 7, which says that 30 per cent of state land in each municipality will be leased out for 30 years on the basis of an investment plan which will be evaluated by a committee set up by the Agriculture Minister. Former Economy Minister Sasa Radulovic, the leader of a political movement called Enough is Enough, told BIRN that this gives the government arbitrary power to decide who can have the land. **RAI, 26 November 2015.**

Balkan Partnerships: Strengthening the Region's Ties

Balkan nations face an array of domestic and external challenges as they grapple with the sudden arrival of refugees using the region to head northwards. Beyond the Tipping Point: Anti-Corruption Works. Governance Works Better

The Romanian Academic Society, an SELDI member, contributed to the elaboration of the *Beyond the Tipping Point: Anti-Corruption Works. Governance Works Better* report. The report is grounded on the idea that poor governance, not corruption, is Romania's greatest problem, as it encourages corruption, which, in turn, decreases the quality of governance, creating a vicious cycle. As such, punitive measures for combatting corruption are welcome but far from sufficient for achieving a clean, functional and efficient system. These must be complemented by prevention mechanisms to ensure integrity and efficiency in public institutions. **Romanian Academic Society**.

Uncovering High-Level
Corruption: CrossNational Corruption
Proxies Using
Government Contracting
Data

Measuring high-level corruption and government favouritism has been the object of extensive scholarly and policy interest with relatively little progress in the last decade. In order to address the lack of reliable indicators, this article develops two objective proxy measures of high-level corruption in public procurement: single bidding in competitive markets and a composite score of tendering 'red flags'. **Government Transparency Institute and digiwhist.eu.**
